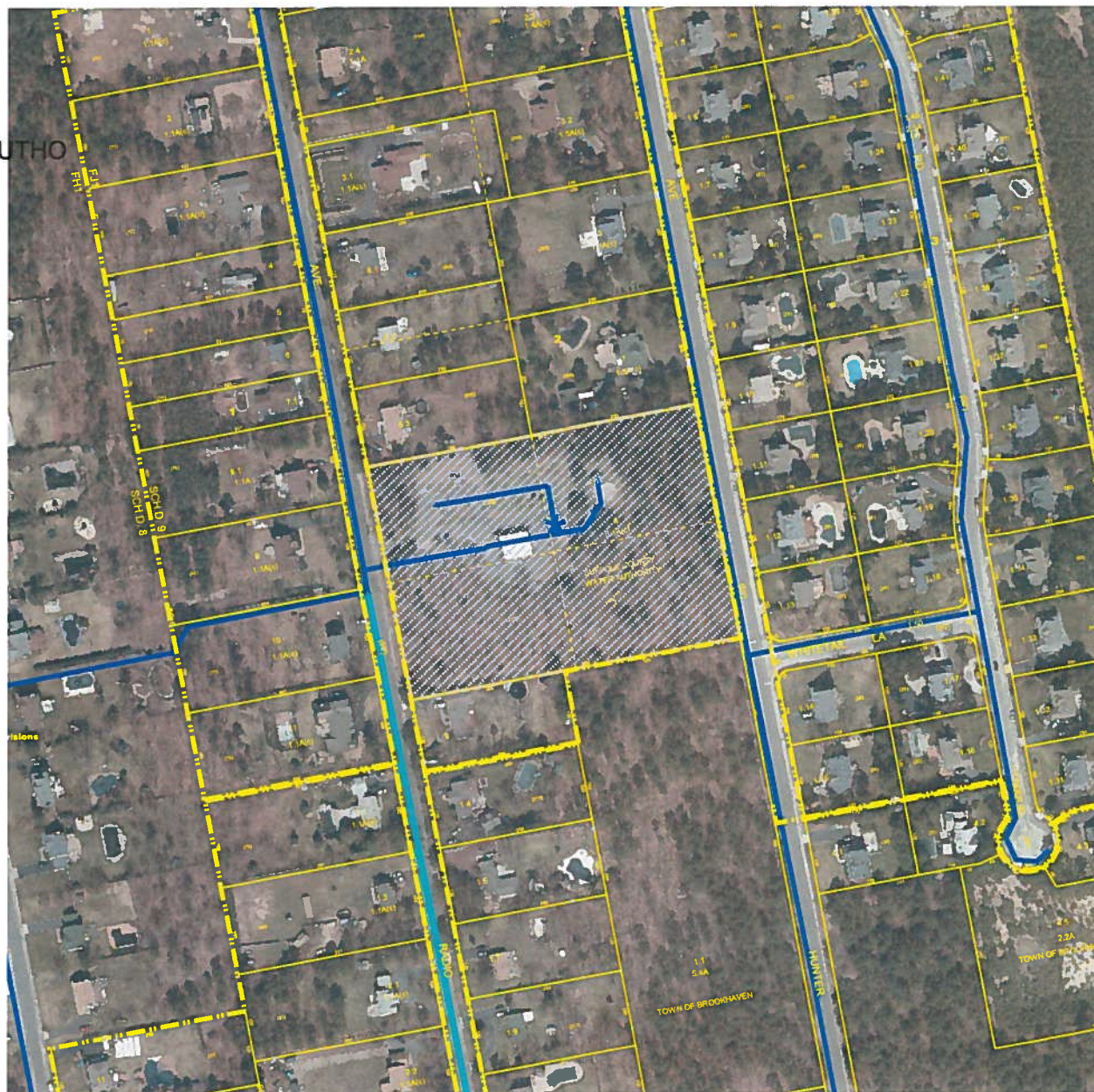
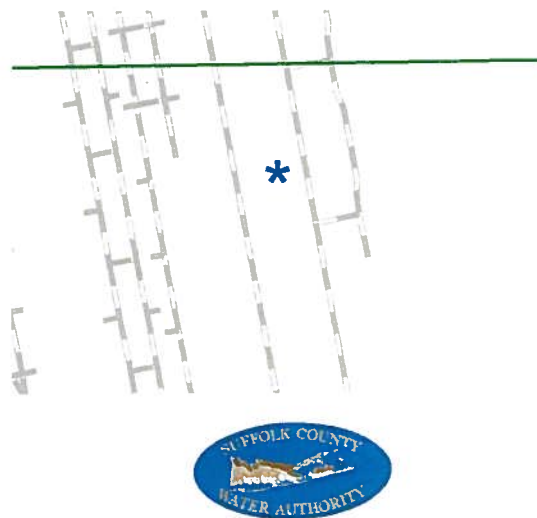

## Radio Avenue

A site inspection of the Radio Avenue well field was performed on November 14, 2014. The ecological community types, as defined by Edinger et al (2014) in “Ecological Communities of New York State, Second Edition,” observed at the well field include a subsystem of forested uplands identified as pitch pine-oak forest; and a subsystem of a terrestrial cultural communities including mowed lawn with trees, and paved road/path.

**Pitch pine-oak forest:** This community type is describes as, “Pitch pine-oak forest: a mixed forest that typically occurs on well-drained, sandy soils of glacial outwash plains or moraines. The dominant trees are pitch pine (*Pinus rigida*) mixed with one or more of the following oaks: scarlet oak (*Quercus coccinea*), white oak (*Q. alba*), red oak (*Q. rubra*), or black oak (*Q. velutina*). The relative proportions of pines and oaks are quite variable within this community type. Examples can range from having widely spaced pines that are often emergent above the oak canopy to a nearly pure stand of pines with only a few widely spaced oak trees. The shrub layer is well-developed with scattered clumps of scrub oak (*Quercus ilicifolia*) and a nearly continuous cover of low heath shrubs such as lowbush blueberries (*Vaccinium pallidum*, *V. angustifolium*) and black huckleberry (*Gaylussacia baccata*).

The herbaceous layer is relatively sparse; characteristic species are bracken fern (*Pteridium aquilinum* var. *latiusculum*), wintergreen (*Gaultheria procumbens*), and Pennsylvania sedge (*Carex pensylvanica*).”

**Mowed lawn with trees:** This community type is describes as, “residential, recreational, or commercial land in which the groundcover is dominated by clipped grasses and forbs, and it is shaded by at least 30% cover of trees. Ornamental and/or native shrubs may be present, usually with less than 50% cover. The groundcover is maintained by mowing and broadleaf herbicide application.” However, applications of herbicides do not typically occur.

**Paved road/path:** This community type is describes as, “A road or pathway that is paved with asphalt, concrete, brick, stone, etc. There may be sparse vegetation rooted in cracks in the paved surface.”

## Wildlife

The New York Natural Heritage Program (NYNHP) was contacted for information regarding the known populations of rare, threatened or endangered species. As indicated in correspondence dated November 12, 2014 (attached), the New York Natural Heritage database has no records of rare or state-listed animals or plants, or of significant natural communities, at the well field site.

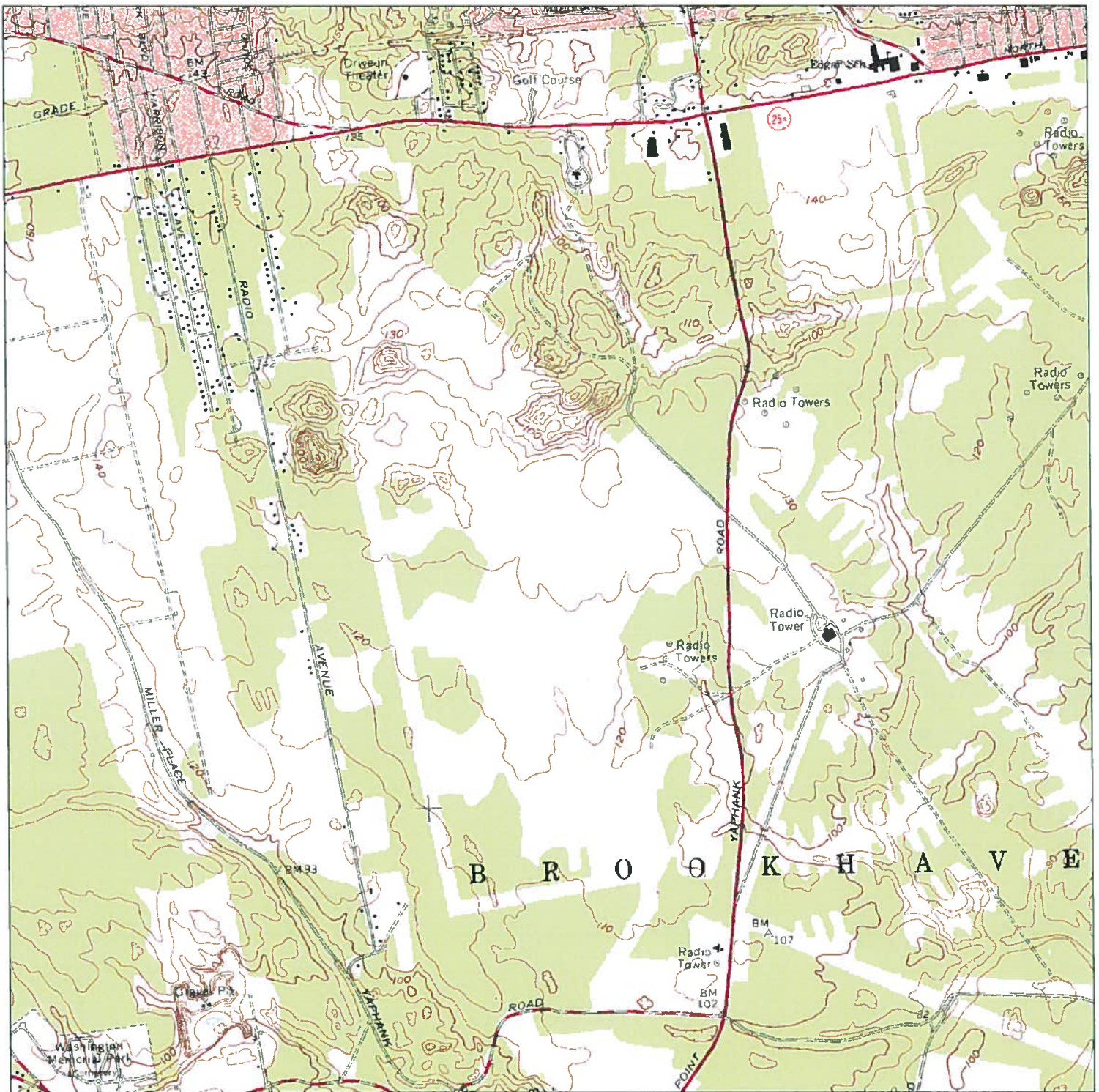
Due to the time of year that site inspection occurred, wildlife including, but not limited to, avian species observations were limited. The New York State Department of Environmental Conservation Breeding Bird Atlas (BBA) was reviewed to obtain a more specific representation of the avian species that may potentially utilize the site for breeding, foraging, and/or stopover habitat. Attached is a copy of the 2000-2005 Breeding Bird survey for the census block encompassing the project site. The BBA census block spans an area covering three square miles.

According to “Ecological Communities of New York State,” “characteristic birds of the pitch pine-oak ecological community with varying abundance include eastern towhee (*Pipilo erythrophthalmus*), common yellowthroat (*Geothlypis trichas*), field sparrow (*Spizella pusilla*), prairie warbler (*Dendroica*

discolor), pine warbler (*Dendroica pinus*), and blue jay (*Cyanocitta cristata*).” Characteristic fauna of the mowed lawn with trees ecological community include “gray squirrel (*Sciurus carolinensis*), American robin (*Turdus migratorius*), mourning dove (*Zenaida macroura*), and northern mockingbird (*Mimus polyglottos*).”
