Booklets containing detailed information for all Agenda items were distributed to each Member, Executive Staff and Counsel to the Authority.

At 3:00 p.m. Chairman Halpin called the meeting to order.

Mr. Halpin then opened the meeting for public comment. At this time, Ellen Corwin, representing the Finance Committee of Founders Village in Southold, New York, along with Patricia O'Neill, President of Founders Village, addressed the Board regarding a request for a credit adjustment to Founders Village HOA. At this time, Ms. Vassallo introduced Ed Lee, Audit Partner, at KPMG.

Mr. Lee distributed the 2019 Audit Results, Financial Statements and the Annual Investment Report which was reviewed with the members. He provided a brief summary of documents and indicated that KPMG will be issuing unmodified opinion on the financial statements. There is also a report on investment compliance which is required by New York State and that report also has an unmodified opinion.
