Mr. Szabo asked if there was anyone present or participating virtually who wished to provide public comment. No one wished to speak to the board at this time.

Mr. Lefkowitz presented the minutes of the regular board meeting on October 17, 2024, and on motion made by Ms. Mercado, duly seconded by Mr. Porchia, and unanimously carried, it was

Mr. Szabo presented the contracts to be considered for extension. After brief explanation on a few items and contract leveling for the future; on motion made by Mr. Rose, duly seconded by Mr. Porchia, and unanimously carried, the following contracts were approved on consent:

(400-11-2024) RESOLVED, To extend for the period beginning April 1, 2025 through March 31, 2026, Contract 7929A to furnish and deliver gate valves & butterfly valves (line items, 1,2,3,4,5 and 9) with T. Mina Supply Inc., Medford, NY

RESOLVED, To extend for the period beginning April 1, 2025, through March 31, 2026, Contract 7937 for maintenance of roofs and gutter systems at various SCWA sites; with Statewide Roofing, Inc, Ronkonkoma, NY

RESOLVED, To extend for the period beginning May 1, 2025, through April 30, 2026, Contract 7956 for maintenance and installation of overhead garage-type doors roll-up doors; with Superior Overhead Door Inc., Selden, NY

(391-10-2024) RESOLVED, To authorize an increase to Item 031-Construction Projects-Tapping in the amount of Eight Hundred Thousand Dollars (\$800,000) and an increase to Item 035-Developer Contracts in the amount of Six Hundred Thousand Dollars (\$600,000); this will increase the capital budget to \$105.8 Million Dollars

The Members considered a request for training. On motion made by Mr. Porchia, duly seconded by Ms. Mercado and unanimously carried, it was

(392-10-2024) RESOLVED, To authorize the attendance of Matthew Charland, Junior Applications Developer to attend the LIMS Labware I Administrator course, to be taken remotely, in the amount of Three Thousand and One Hundred Dollars (\$3,100).

On motion made by Mr. Porchia, duly seconded by Mr. Bishop and the following resolution was unanimously carried,

WHEREAS, at the June 18, 2024 Board Meeting, the board awarded Contract 8039-Construction of Well Head Enclosure Buildings with Precast Concrete Walls and Wood Frame Roofs on Existing Foundations to D.F. Eastwood Construction Corp d/b/a All Island Fence & Railing ("D.F. Eastwood") as low bidder, in the amount of Nine Hundred Eighty-four Thousand Nine Hundred Dollars (\$984,900); and

WHEREAS, this award was made following a pre-award meeting where terms were reiterated including fixed unit prices, the inability of the Authority to determine in advance the exact quantity of buildings to be constructed, and payment structure; and

WHEREAS, on October 16, 2024, members of the Engineering team with D.F. Eastwood wherein DF Eastwood, demanded payment up front. The contract provides for progress payments; SCWA progress payments are made upon completion of at least substantial completion of work; and

WHEREAS, Engineering will continue to work with D.F. Eastwood in an attempt to resolve the impasse and D.F. Eastwood's refusal to abide by the terms of the contract and SCWA's progress payment practice; and

WHEREAS, in the event a resolution cannot be achieved, and for the purposes of expediency and in accordance with the department's recommendation; therefore, be it

RESOLVED that the board authorizes the CEO to execute any and all documents required to rescind or cancel this contract together with the preservation of all rights for the Authority to seek damages through available remedies; and be it

FURTHER RESOLVED, that upon cancelation, the board further delegates to the CEO, the authority to award Contract 8039 to the next responsive bidder.

As there was no further business to be considered, the meeting was adjourned at 4:30 p.m.
