SUBJECT: SCWA – ESRI Advantage Program

With the ever increasing use and advancement of technology at SCWA, there is a reasonable expectation that information should be more quickly and readily available. While SCWA consists of many diverse groups that work closely and cooperatively together, these departments seek to share critical information more easily and seamlessly, in a timelier manner. This is especially true for route mapping and visualizing critical infrastructure, such as water mains, fire hydrants, street valves and other essential features.

Currently with the existing SCWA infrastructure we are running all applications and services under a Sun Solaris UNIX server with a backend Oracle Database and Windows Server. All of our current mapping services currently exist under a single windows platform. Under this current environment we are prevented from upgrading ArcGIS Enterprise server without impacting existing applications such as Clevest. In addition, we are prevented from upgrading critical routing services data that is necessary for field personnel using Clevest mobile. There is a critical need in our current system architecture to allow for greater flexibility and to keep up to date services and continue to transition from an outdated UNIX environment with limited support.

We are requesting enter into an agreement with ESRI under the ESRI advantage program (AP). Through this agreement ESRI will work with current staff to coordinate and develop an appropriate system architecture, address all known infrastructure challenges and propose architecture design alternatives. The ESRI consultant will assist in installing and configuring a virtual environment, install and configure ArcGIS Enterprise environment (Portal for ArcGIS, image services, mapping services and geocoding). The services provided by the ESRI advantage program are allocated with service credits. Unused credits would be available for training, workshops and supplemental projects.

The cost of the ESRI Advantage program is \$92,200 for one year and the services of ESRI are procured directly through a New York State Contract (Contract #PM67345). The Authority is permitted to utilize New York State contracts which are competitively bid.

SUBJECT: New Rx Safety Glasses Carrier- General Vision Services (GVS)

Attached to our vision insurance plan is an annual rider for Davis Vision to provide prescription safety glasses to eligible employees. This rider was originally created in 2007 for the electricians in Production Control.

The feedback from both the Safety department and the employees has been unsatisfactory. There are continuous, time-consuming problems with this program including inexperienced staff in Davis Vision stores, long wait times, claims not being handled correctly and more. This past year we piloted utilizing an internet-based safety vision program and have not been pleased with those results.

Additionally, the Safety department would like this program to include other departments where employees may need safety glasses if they wear corrective lenses. If we remain with Davis Vision, we will be required to pay an additional administration fee. Potentially, we will have more utilization by opening this up to the eligible population and we need a more efficient program.

For the 2020 plan year our broker marketed the plan to locate other providers who would be able to supply prescription safety glasses to our workforce. There was just one company who was able to provide a proposal for this type of program without holding our general vision insurance plan. General Vision Services (GVS) comes highly recommended by a colleague in the utility field. They partner with 7 retail stores (Cohen Optical, Sterling, Pearle) across Suffolk County specifically designated to administer prescription safety glasses.

GVS is proposing a flat rate. The fee is \$165.00 per pair of glasses. Over the past 3 plan years the average number of employees who obtained prescription safety glasses was 3 employees per year.

Based on the above information, *it is recommended that we offer the prescription safety glasses program through General Vision Services (GVS) of New York, New York for a three-year period effective January 1, 2020.* If you concur, please add this item to the Board agenda for the November 2019 meeting.

SUBJECT: WATER REVENUE BONDS SERIES 2014C

As a result of the Federal Disaster Relief Appropriations Act, to mitigate extreme weather occurrences such as Super Storm Sandy of 2012, Congress appropriated \$600,000,000 in the State Revolving Funds for New York and New Jersey to reduce vulnerability or enhance resilience involving treatment works. In 2014, New York established the Storm Mitigation Loan Program (SMLP) to assist local governments in strengthening long-term resilience for wastewater and drinking water treatment facilities in areas impacted by Hurricane Sandy.

In October 2014, the Board authorized a board resolution (415-10-2014), prepared by Harris Beach, for the issuance of Water Revenue Bonds Series 2014C with the Environmental Facilities Corporation (EFC). This issuance utilized Storm Mitigation Loan Program and was not to exceed \$27,000,000.

The projects of the Authority for the Storm Mitigation Loan program are the water main installations of Huntington, Noyac, Cherry Grove, and 52 generators.

In June of 2015, the Authority determined it financially advantageous to issue Bond Anticipation Notes, short-term instruments of less than five years, instead of Bonds, long-term instruments, for the Storm Mitigation Loan program. Board resolution 212-06-2015 was prepared by Harris Beach, and approved by the Board, authorizing the issuance of **Bond Anticipation Notes 2015A**, short term notes for the EFC-Storm Mitigation Loan Program not to exceed \$27,000,000. The Bond Anticipation Notes 2015A are a 5-year maximum term, in which the Authority would pay off the BANS or have the BANS convert to long term debt.

The Authority provided a budget of \$22,000,000 at closing to the EFC for SMLP. The Authority would receive 75% as an interest free loan not to exceed \$16,500,000, and 25% as a grant not to exceed \$5,500,000. The expected loan amount is approximately \$10,300,000 and \$3,500,000 of grant money.

Attached is a supplemental resolution, prepared by Harris Beach, authorizing the retirement of the Bond Anticipation Notes 2015A and authorizing the issuance of **Water System Revenue Bond Series 2020A** with a final maturity not to extend beyond June 1, 2050.

A SUPPLEMENTAL RESOLUTION AUTHORIZING THE SUFFOLK COUNTY WATER AUTHORITY'S PARTICIPATION IN THE NEW YORK STATE ENVIRONMENTAL FACILITIES CORPORATION DRINKING WATER **REVOLVING FUND PROGRAM AND, IN CONNECTION THEREWITH,** AUTHORIZING AND DESIGNATING THE ISSUANCE AND PROVIDING FOR THE TERMS OF NOT TO EXCEED TWENTY-SEVEN MILLION DOLLARS (\$27,000,000) OF SENIOR LIEN BONDS OF THE SUFFOLK COUNTY WATER **AUTHORITY PREVIOUSLY AUTHORIZED UNDER THE AUTHORITY'S** SUPPLEMENTAL RESOLUTION NO. 415-10-2014; DELEGATING TO THE CHAIRMAN, THE CHIEF EXECUTIVE OFFICER AND/OR THE CHIEF FINANCIAL OFFICER OF THE AUTHORITY THE POWER TO (I) DETERMINE CERTAIN TERMS OF SAID BONDS AND TO TAKE ANY AND ALL ACTION NECESSARY TO PROVIDE FOR THE ISSUANCE OF SAID BONDS, (II) ISSUE AND DELIVER SAID BONDS TO SAID CORPORATION, AND (III) DETERMINE THE TERMS AND CONDITIONS OF, AND EXECUTE AND DELIVER ON BEHALF OF THE AUTHORITY A PROJECT FINANCE AGREEMENT TO BE ENTERED INTO BETWEEN THE AUTHORITY AND SAID CORPORATION IN CONNECTION WITH THE AUTHORITY'S PARTICIPATION IN SAID DRINKING **REVOLVING FUND** WATER PROGRAM, AND TO EXECUTE AND DELIVER SUCH OTHER DOCUMENTS. **CERTIFICATES AND AGREEMENTS NECESSARY FOR THE AUTHORITY'S** PARTICIPATION IN SAID PROGRAM; AND APPOINTING THE PAYING AGENT AND REGISTRAR AND, AUTHORIZING RELATED MATTERS.

WHEREAS, the Suffolk County Water Authority (the "Authority") adopted on September 27, 1988 a resolution authorizing and providing for the issuance of revenue bonds of the Authority for the purposes of the Water System of the Authority, as amended by resolutions adopted by the Authority on October 27, 1988, March 30, 1993 and November 29, 1994 (the "Bond Resolution"); and

WHEREAS, the Authority is planning various improvements to its Water System and it is deemed advisable to fund such improvements through the issuance of its bonds; and

WHEREAS, the New York State Environmental Facilities Corporation, a body corporate and politic constituting a public benefit corporation of the State of New York ("EFC"), is authorized to make a long term loans to municipalities and public corporations, including the Authority, for the purpose of financing the costs of certain eligible projects pursuant to its Drinking Water Revolving Fund Program (the "Program"); and

WHEREAS, the Authority submitted an application to participate in the Program with regard to certain projects relating to the Water System of the Authority (the "Projects") and the Authority was notified that its application was approved; and WHEREAS, the Authority has made certain determinations under the New York State Environmental Quality Review Act (Article Eight of the Environmental Conservation Law) ("SEQRA") with respect to the Projects as shown in <u>Schedule A</u> hereto; and

WHEREAS, pursuant to the Bond Resolution and Supplemental Resolution No. 415-10-2014 adopted by the Authority on October 30, 2014 (the "2014C Series Bonds Supplemental Resolution"), the Authority authorized the Authority's participation in the Program and the issuance of a Series of Senior Lien Bonds in the total principal amount of not to exceed Twenty-Seven Million Dollars (\$27,000,000) ("Series Bonds") for the purpose of financing the Projects (as described in such Series Bonds Supplemental Resolution and as more particularly described in <u>Schedule A</u> hereto; provided however that the component described in line item "a" of Schedule A, will not be financed from the long term loan from EFC as hereinafter described); and

WHEREAS, pursuant to the Bond Resolution, the 2014C Series Bonds Supplemental Resolution and Supplemental Resolution No. 212-06-2015 adopted by the Authority on June 29, 2015 (the "Note Supplemental Resolution"), the Authority has further determined it advisable and financially advantageous to issue its bond anticipation notes in an aggregate principal amount not to exceed \$27,000,000 in anticipation of the issuance of its Series Bonds and to deliver such bond anticipation notes to EFC; and

WHEREAS, pursuant to the Bond Resolution and Note Supplemental Resolution, the Authority has heretofore issued its \$16,538,558 E.F.C Drinking Water Facility Note – 2015A (Bond Anticipation Note) (the "2015A Note"); and

WHEREAS, in order for the Authority to participate in the Program and obtain a long term loan from EFC to finance the Projects and retire the 2015A Note, it will be necessary for the Authority to issue its revenue bonds to EFC to evidence the Authority's obligation to repay such loan; and

WHEREAS, the Authority has determined it advisable and financially advantageous to borrow from EFC, as a participant of the Program, an amount not to exceed \$27,000,000 and to issue and deliver its Senior Lien Bonds to EFC, in a like amount, in order to evidence its obligation to repay such loan; and

WHEREAS, the Authority has further determined it advisable and financially advantageous to (i) fund a reserve account for such Senior Lien Bonds, (ii) use the proceeds of the long term loan from EFC to retire all of the outstanding 2015A Note held by EFC and (iii) finance, with the balance of the long term loan from EFC all or a portion of the costs of issuing such Senior Lien Bonds or, pay from Net Revenues for all or a portion of the costs of issuing such Senior Lien Bonds; NOW, THEREFORE,

BE IT RESOLVED BY THE SUFFOLK COUNTY WATER AUTHORITY, as follows:

SECTION 1. Definitions. (A) Unless the context shall clearly indicate some other meaning, all words and terms used in this Supplemental Resolution which are defined in the Bond Resolution shall for all purposes of this Supplemental Resolution have the respective meanings given to them in the Bond Resolution. (B) Unless or except as the context shall clearly indicate otherwise or may otherwise require in this Supplemental Resolution: (i) all references to a particular Article, section and/or subdivision of the Bond Resolution or this Supplemental Resolution, as the case may be, are to the corresponding Article, section or subdivision of the Bond Resolution only, or this Supplemental Resolution only, as the case may be; (ii) the terms "herein," "hereunder," "hereby," "hereto," "hereof," and any similar terms refer to this Supplemental Resolution as a whole and not to any particular section or subdivision hereof; (iii) the terms "therein," "thereunder," "thereby," "thereto," "thereof," and any similar terms, refer to the Bond Resolution and to the Bond Resolution as a whole and not to any particular Article, section or subdivision thereof; and (iv) the term "heretofore" means before the time of effectiveness of this Supplemental Resolution and the term "hereafter" means after the time of effectiveness of this Supplemental Resolution.

SECTION 2. <u>Authorization of EFC Borrowing and Finance</u> <u>Agreement: Authorization and Designation of Senior Lien Bonds.</u> (A) The Authority is hereby authorized to participate in the Program and to obtain a long term loan from EFC in the total principal amount not to exceed Twenty-Seven Million Dollars (\$27,000,000) (the "Loan") (i) to provide moneys for the retirement of all of the outstanding 2015A Note pursuant to the provisions of Section 7 hereof and (ii) finance, with the balance thereof, all or a portion of the costs of issuing such Senior Lien Bonds. In connection therewith, the Authority is hereby further authorized to enter into a Project Finance Agreement (the "Finance Agreement") with EFC and any and all other agreements necessary or convenient therewith. In connection therewith, the Authority is hereby further authorized to (i) fund a reserve account for the Senior Lien Bonds authorized in Paragraph (B) below, pursuant to the provisions of Section 6 hereof and to pay for all or a portion of the costs of issuing such Senior Lien Bonds,

(B) In order to evidence the Authority's obligation to repay the Loan, the Authority is hereby authorized to issue and deliver to EFC its Senior Lien Bonds authorized to be issued by the Bond Resolution and this Supplemental Resolution, as provided below, in an aggregate amount not to exceed Twenty-Seven Million Dollars (\$27,000,000), which Senior Lien Bonds shall be designated "Water System Revenue Bonds, Series 2020A (EFC Series)" or such other title as the Chairman of the Authority determines in the Certificate of Determination referred to in Paragraph (C) below (the "Series 2020A Bonds").

(C) The Series 2020A Bonds shall have such terms, conditions and details as shall be provided in a certificate to be executed by the Chairman of the Authority subsequent to the date hereof pursuant to Section 3 of this Supplemental Resolution (the "Certificate of Determination"). In addition, the final terms, conditions and details of the Finance Agreement, including, without limitation, the payment provisions thereof, shall be provided in the Certificate of Determination. In the event that the Chairman determines to issue, initially, less than the maximum principal amount of Series 2020A Bonds authorized to be issued hereunder and under the Bond Resolution, any subsequent issue of such Series 2020A Bonds are subject to the provisions of Paragraph B above and may be subject to the terms and conditions to be set forth or delegated to the Chairman in a separate supplemental resolution of the Authority to be adopted on a future date. The Series 2020A Bonds shall be and are hereby designated as Senior Lien Bonds. SECTION 3. <u>Delegation to Chairman</u>. There is hereby delegated to the Chairman of the Authority, subject to the limitations contained herein and in the Bond Resolution, the power with respect to the Series 2020A Bonds, and in connection with the funding of the Loan to the Authority out of the proceeds of the EFC Bonds pursuant to the Finance Agreement, to determine and carry out the following terms which shall be set forth in the Certificate of Determination:

(a) The final aggregate principal amount of the Series 2020A Bonds, which shall not exceed the maximum principal amount authorized by this Supplemental Resolution, the principal amortization schedule of the Series 2020A Bonds, and the date, maturity date or dates and interest payment dates of the Series 2020A Bonds; provided, however, that the final maturity of the Series 2020A Bonds shall not extend beyond June 1, 2050, or otherwise exceed the limitations provided in the Act;

(b) The solicitation of ratings for the Series 2020A Bonds;

(c) The interest rate or rates of the Series 2020A Bonds, to be determined upon the execution of a Notice of Terms or similar certificate delivered pursuant to the provisions of the Finance Agreement;

(d) The denominations of and manner of numbering and lettering the Series 2020A Bonds;

(e) Whether the Series 2020A Bonds will be issued in fully registered form or in any other form permitted under the Bond Resolution, the privileges, if any, of convertibility from one form to another, and the place or places of such registration and conversion;

(f) The redemption provisions, if any, relating to the Series 2020A Bonds;

(g) If any of the Series 2020A Bonds are to be issued as Term Bonds, the amount and due dates of each sinking fund installment for the Term Bonds of such Series, and the date or dates and redemption price or prices upon which the Term Bonds of the Series may be redeemed from such installments, and the manner and procedure of applying such installments to the redemption of the Term Bonds of such Series;

(h) The place or places of payment of the Series 2020A Bonds and premium, if any, and interest thereon;

(i) The use, application and investment, if any, of the proceeds of such sale of the 2020A Bonds, which use, application and investment shall not be inconsistent or in conflict with the provisions of the Bond Resolution;

(j) The identity of the provider or providers of any Additional Security for the 2020A Bonds, and the execution of any agreements relating to said Additional Security with the providers thereof. In the event that the Chairman determines to obtain any Additional Security for the 2020A Bonds, the terms and conditions relating thereto shall be set forth in the Certificate of Determination;

(k) Whether the Reserve Account, Series 2020A, referred to below shall be

funded with Net Revenues or a letter of credit, surety agreement or an insurance agreement and the negotiation and execution of any agreements relating to any such letter of credit, surety agreement or an insurance agreement;

(l) The terms and conditions of the Finance Agreement and any other agreement, document or certificate required by EFC in connection with the Authority's participation in the Program; and

(m) Any other provisions which may be required to be inserted in such Certificate of Determination by the provisions of the Bond Resolution, this Supplemental Resolution or any other necessary or desirable provisions not inconsistent or in conflict with the provisions of the Bond Resolution; and the taking of any and all action necessary to provide for the issuance of the Series 2020A Bonds and in connection with the funding of the Loan, including the execution and delivery of the Finance Agreement and of any required documents, certificates and agreements, closing documents and tax and arbitrage certificates.

SECTION 4. <u>Issuance and Delivery of Series 2020A Bonds</u>. The Series 2020A Bonds shall be issued and delivered to EFC to evidence the Authority's obligation to repay the Loan to the Authority pursuant to the Finance Agreement. The Chairman, the Chief Executive Officer and/or the Chief Financial Officer and other officers, employees, agents and attorneys of the Authority are hereby authorized to take any and all action necessary to provide for the issuance and delivery of the Series 2020A Bonds to EFC, including the preparation of materials or information necessary for inclusion in the official statement relating to the EFC Bonds.

SECTION 5. <u>Appointment of Paying Agent, Registrar and Construction</u> <u>Fund Trustee.</u> The Bank of New York Mellon, New York, New York, is hereby appointed Paying Agent and Registrar for the Series 2020A Bonds. Pursuant to Section 7.1 of the Bond Resolution, the Authority hereby appoints The Bank of New York, New York, New York, as Construction Fund Trustee for the Construction Fund created for the Series 2020A Bonds in Section 7 of this Supplemental Resolution.

SECTION 6. Senior Lien Bond Reserve Account, Series 2020A. There is hereby created in the Bond Fund a reserve account for the Series 2020A Bonds to be known as the "Reserve Account, Series 2020A" or as otherwise designated by the Chairman of the Authority in the Certificate of Determination. Moneys in the Reserve Account, Series 2020A, shall be applied as provided in the Bond Resolution. The Reserve Account Requirement for the Series 2020A Bonds shall be the average of the annual installments of Debt Service with respect to all Series 2020A Bonds outstanding for the then current and all future Fiscal Years.

The Reserve Account Requirement for the Series 2020A Bonds shall be funded from Net Revenues or shall otherwise be satisfied as set forth below. If the Reserve Account Requirement is to be funded from Net Revenues, moneys in the Water Revenue Fund shall be deposited monthly in equal installments commencing the month after the date of the payment for and delivery of the Series 2020A Bonds (the "Closing Date") into the Bond Fund for credit to the Reserve Account, Series 2020A, such that there shall be on credit thereto an amount equal to the Reserve Account Requirement on or prior to the twentyfourth month after the Closing Date (or such shorter period as the Chairman of the Authority determines in the Certificate of Determination). To the extent of any deficiency therein at any time the Authority, after making the deposits to the Operating Fund, the Original Bonds Trust Fund as provided in Section 6.1 of the Bond Resolution, the Interest Account, Principal Account and Bond Retirement Account in the Bond Fund and the Secondary Interest Account, Secondary Principal Account and Secondary Bond Retirement Account in the Secondary Bond Fund, shall deposit with the Bond Fund Trustee in the Bond Fund for credit to the Reserve Account, Series 2020A, therein from moneys in the Water Revenue Fund an amount sufficient to make up such deficiency.

Notwithstanding any limitations set forth in Section 6.10 of the Bond Resolution as to the term to maturity of investments in any Reserve Account, investments in the Reserve Account, Series 2020A, shall mature at such time or times as the Authority shall decide as evidenced in the Certificate of Determination.

In satisfaction of the Reserve Account Requirement for the 2020A Bonds and in an amount equal thereto the Authority may provide a letter of credit, surety agreement, insurance agreement or other type of agreement or arrangement with any entity whose obligations are rated in one of the two (2) highest rating categories by Standard & Poor's Ratings Services, or Moody's Investors Service (a "Credit Agreement"). The Authority, at its discretion, shall have the authority to substitute a Credit Agreement, if not initially provided, for all or a portion of the amounts in the Reserve Account, Series 2020A. If at any time the rating issued by Standard & Poor's Ratings Services or Moody's Investors Service of obligations of the issuer of the Credit Agreement shall fall below such two (2) highest ratings, then within twelve (12) months thereafter the Authority shall (i) use its best efforts to, and, if available, replace such Credit Agreement with a Credit Agreement issued by an entity having obligations so rated within such two (2) highest rating categories, or (ii) deposit into the Reserve Account, Series 2020A, moneys in replacement of such Credit Agreement. On or before the date which is six (6) months prior to the expiration of such Credit Agreement the Authority shall either procure a replacement Credit Agreement or provide moneys in substitution therefor. Upon the delivery of such Credit Agreement to the Bond Fund Trustee, the amounts in the Reserve Account, Series 2020A, equal to the amount specified in the Credit Agreement shall be deposited in the New Construction Fund and used for improvements to the Water System. The Chairman, the Chief Executive Officer and/or the Chief Financial Officer are hereby authorized to execute and deliver any such Credit Agreement and any repayment agreement relating thereto on behalf of the Authority.

SECTION 7. <u>Construction Fund</u>. There is hereby created and established a separate trust fund of the Authority to be known as the "Construction Fund, Series 2020A" or as otherwise designated by the Chairman of the Authority in the Certificate of Determination, to be held by the Construction Fund Trustee. Moneys in the Construction Fund, Series 2020A, shall be applied solely to finance the Cost of Acquisition and Construction of the Water System, including financing all or a portion of the costs of issuing the Series 2020A Bonds.

SECTION 8. <u>Application of Proceeds of Sale of the Series 2020A Bonds.</u> Proceeds of the sale of the Series 2020A Bonds shall be applied as follows: A portion of the proceeds of the Series 2020A Bonds in an amount sufficient to pay all or a portion of the costs of issuing such 2020A Bonds shall be deposited in the Construction Fund and the 2015A Note will be cancelled and returned to the Authority upon the issuance of the 2020A Bond to EFC.

SECTION 9. <u>CUSIP Identification Numbers.</u> CUSIP identification numbers, at the sole option of the Authority, may be placed on the Series 2020A Bonds but neither the failure to place any such number on any Series 2020A Bond nor any inaccuracy, error or omission with respect thereto shall constitute cause for failure or refusal by the purchasers to accept delivery of and pay for the Series 2020A Bonds. No such CUSIP identification number shall constitute a part of the contract evidenced by the particular Series 2020A Bond upon which it is imprinted and no liability shall attach to the Authority or any officer or agent thereof, including any Registrar or Paying Agent for the Series 2020A Bonds, by reason of such number or any use made thereof, including any use thereof made by the Authority, any such officer or any such agent, or by reason of any inaccuracy, error or omission with respect thereto or in such use.

SECTION 10. <u>Effect of Section Headings</u>. The headings or titles to the several Sections hereof shall be solely for convenience of reference and shall not affect the meaning, construction, interpretation or effect of this Supplemental Resolution.

SECTION 11. <u>Repeal of Inconsistent Resolutions</u>. Any resolution (other than the Bond Resolution) of the Authority, or any portion thereof, in conflict or inconsistent with this Supplemental Resolution is hereby repealed to the extent of such conflict or inconsistency.

SECTION 12. <u>Effective Date.</u> This Supplemental Resolution shall take effect upon its adoption.

SUBJECT: Michael Murphy Navy Seal Museum - Sayville

During the October 2019 Board meeting, representatives from the Michael Murphy Navy Seal Museum, which is being built in Sayville, addressed our Board and requested a reduction in the fees associated with fire and water service to this new facility. The domestic tap and fireline tap fees include a 10% discount for running services in the same trench. The fees associated with this project were quoted by our New Service department as follows:

2" Vault	\$ 1,460.00
2" Deposit	\$ 100.00
6" Fireline Tap	\$ 13,950.00
6" Deposit	\$ 300.00
Total	\$ 21,390.00

The Suffolk County Water Authority's rules specifically preclude the Authority from providing services free of charge. As a result, the Board was limited in what SCWA could offer the museum. However, subsequent to the meeting, Board member Mattera proposed a solution whereby several different entities would provide labor, materials, and funds to the Authority that would supplement the tapping fees. The proposal is as follows:

- Bancker Construction of Holtsville will provide the labor to make both taps and run the service lines within the public right of way
- Adjo Contracting of Bohemia will perform the saw cutting and restoration of the road and act as a subcontractor to Bancker
- SCWA will provide all materials and will be reimbursed by the plumbers of Local 200
- SCWA will furnish inspection services for the pipe work in addition to obtaining the road opening permit. Local 200 will reimburse the Authority for the labor costs.

By working in this manner, SCWA ensures that all costs associated with the tapping fees will be recovered; Bancker will perform the work under the existing pipeline contract and Adjo will work as a subcontractor for Bancker under the same contract. Insurance for both contractors will be provided pursuant to the terms of the current established contract. In addition, Local 200 will reimburse the Authority for the material and labor costs associated with this project.

The new Generators recently purchased and installed over the past few years with the use of SMLP Grant money all have Enclosures that require our employees to step up and into the Enclosures. The step up is approximately 19 inches high and this has caused concerns with our employees and the Safety Committee has asked for a solution to this problem. To address this problem we designed an aluminum step that can be easily installed on the existing concrete walk way outside the Generator Enclosure. There are approximately 45 Generator Enclosures and we propose to install a new step at each Enclosure.

An RFQ was sent to three vendors for forty five (45) Steps; and we received three quotes as shown in the table below:
