

#### Important information from the Suffolk County Department of Health Services

Beginning July 1, 2019, new cesspools will no longer be allowed as replacements for old cesspools in Suffolk County. There is no requirement for homeowners to replace their existing cesspools or septic systems. If an existing cesspool is replaced, however, the Suffolk County Sanitary Code now requires that the replacement system must include a septic tank. This is the same requirement that has been in place for new construction since 1973.
