and unanimously carried, it was

(235-07-2017) RESOLVED, To authorize the purchase of a one-year service agreement beginning October 1, 2017, for the Laboratory's Instruments, which includes one preventative maintenance visit plus parts, labor and travel, from Agilent Technologies, Inc. of Wilmington, Delaware, in the total amount of Thirty-Two Thousand Six Hundred Fifty and 20/100 (\$32,650.20); and that any Member and/or the Chief Executive Officer be and hereby is authorized to execute this agreement on behalf of the Authority.

Eurofins Laboratories for Assimiliable Organic Carbon in the amount of Ten Thousand Dollars (\$10,000).
