10. Budget

a) Budget Amendment #1 - May 31, 2018

Authorize revision to the budget for year ending May 31, 2017, as follows:

Decrease to Item 030-18 (Services) in the amount of \$250,000;

Increase to Item 031-18 (Construction Contracts-Tapping) in the amount of \$250,000.

This transfer will not increase the current capital budget of \$71,360,000.
